OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **ENTRIES:** Limit one entry per person, per e-mail address, per quarter for the Customer Service Survey Quarterly Giveaway (“Giveaway”). Should a dispute arise as to the identity of an online entrant, the prize will be awarded to the authorized account holder of the e-mail address. The "authorized account holder" is defined as the natural person to whom the email address is assigned by an Internet Service Provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.
2. **ELIGIBILITY:** Open to all customers who visit Gateway Aviation Services and correctly completes a customer service survey and provides an accurate address, phone number, and/or e-mail address. This Giveaway is not open to any Government employees, or to Phoenix-Mesa Gateway Airport Authority (PMGAA) employees and their families. Entrants may only win one prize per year.
3. **CONDITIONS OF PARTICIPATION:** Entrants must have a valid e-mail address. It is the entrant's responsibility to notify Gateway Aviation Services of any change in e-mail address. Expenses not specifically included in the Giveaway including all taxes are the sole responsibility of the winner. Each prize is awarded "as is" with no warranty or guarantee, either express or implied outside of manufacturer's limited warranty. No transfer, assignment or substitution of a prize is permitted, except Gateway Aviation Services reserves the right to substitute prize for an item of equal or greater value in the event an advertised prize is unavailable. All federal, state, provincial, and local laws and regulations apply. Entrants agree to be bound by the terms of these Official Rules and by the decisions of PMGAA, which are final and binding on all matters pertaining to this Giveaway. Winners (and parent or legal guardian if winner is a minor) will be required to sign and return an Affidavit of Eligibility, a Liability Release and where legally permissible a Publicity Release within seven days following the date of first attempted notification. Failure to comply with this deadline may result in forfeiture of the prize and selection of an alternate winner. Return of any prize/prize notification as undeliverable may result in disqualification and selection of an alternate winner. Winner hereby further agrees that he/she will sign any documents necessary to transfer copyright of the entry to PMGAA within seven days following the date of first attempted notification. DISPUTES/CHOICE OF LAW: Except where prohibited, each entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Giveaway or any prize awarded, shall be resolved individually, without resort to any form of class action, and exclusively by state or federal courts situated in Arizona; (2) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; (3) no punitive, incidental, special, consequential, or other damages, including without limitation, lost profits may be awarded (collectively, "Special Damages"); and (4) entrant hereby waives all rights to claim Special Damages and all rights to have such damages multiplied or increased.
